

SCHOOL LIBRARY:

Elite Permanent Makeup & Cosmetology College offers students an online resources. In addition to 30 hardcover hair, skin, and makeup books, The video library consists of a yearly only subscription of Behind the Chair videos and tutorials, which students will have access to for 1 year after graduation. Access to social media accounts to demonstrate work performed. The techniques of this field are ever-evolving, and are provided to students in “real time” which are updated monthly. Students are not permitted to take these books home, but are free to take pictures with their cell phones and/or we can email them whatever item they wish to refer to. These are available to students at any time during open business hours. There are no library fees.

PARKING:

Students must abide by local (city and/or landlord) parking rules which are explained during orientation. College is not responsible for parking violations and or storage fees. College does not have a designated parking for students.

HOUSING:

Elite Permanent Makeup & Cosmetology College does not offer on-campus dormitory housing. Los Angeles has a high cost of living. Expected non institutional costs for students who do not live within commuting distance should be expected. Housing can cost between 1,600-2,000 a month for a rental. The institution has no responsibility to find or assist students in finding housing.

DISABLED STUDENTS:

Access for disabled students to the institution's facilities is available. This institution does offer programs for the disabled student depending on the physical ability of the potential student.

STATEMENT-NON-DISCRIMINATION:

Elite Permanent Makeup & Cosmetology College does not discriminate on the basis of race, color, religion, ethnic origin, sex, handicap, financial status, age, area of origin or residence in its admissions, instruction, or graduation policies.

FINANCIAL STATEMENT:

Our college is not involved in any type of Bankruptcy action such as having a pending petition before a Bankruptcy court, or operating as a debtor in possession nor have we filed a petition within the preceding five years or have had a petition in bankruptcy filed against it within the preceding five years that resulted in reorganization under Chapter 11 of the United States Bankruptcy Code (11 U.S.C. Sec. 1101 et seq.)

LANGUAGE DISCLOSURE :

Elite Permanent Makeup & Cosmetology College does not offer English as a Second Language (ESL) courses. All prospective students must demonstrate proficiency in the English language prior to enrollment. The minimum standard for English language proficiency is the completion of 10th grade at a United States high school. Applicants who did not complete high school in the United States must provide official high school or college transcripts showing successful completion of at least three years of English language coursework. If the College determines that an applicant's English skills are insufficient to successfully complete the program, the applicant will not be admitted.

FRESHMAN PHASE:

The freshman curriculum for each course requires a specific number of hours of classroom lectures, demonstrations, and student practice. The freshman phase teaches you from the very beginning and introduces the basics for those areas that you will need to know to pass licensing examinations. From this initial introduction, you will learn all fundamentals that are the basics for your future and career. The hours spent as a freshman are 15% of the selected program hours. Elite Permanent Makeup & Cosmetology College considers the freshman phase to be the foundation for your future.

TEXTBOOKS, EQUIPMENT & SUPPLIES:

Textbooks and kits will be issued after the cancellation period. All needed school supplies and equipment are the responsibility of the student to bring to class when needed. The kit contains the equipment necessary for satisfactory completion of the course. Students are expected to maintain the kit by replacing lost or broken articles. The college is not responsible for a student's equipment, either lost or stolen. Students must learn to be responsible for the tools of their trade.

CLASS SCHEDULES:

Classes Operate Weekly: The week starts on Monday and ends on Friday.

Full Time - (Based on 30 hours of instruction each week.)

1000hr Cosmetology program is a 34-week program.

600hr Esthetics program is a 20-week course.

400hr Manicure program is a 14-week program.

600hr Hairstyling program is a 20-week course.

Part Time - (Based on 22.5 hours of instruction each week.)

1000hr Cosmetology program is a 45-week program.

600hr Esthetics program is a 27-week course.

400hr Manicure program is a 18-week program.

600hr Hairstyling program is a 27-week course.

ORIENTATION:

An orientation session is held for all students prior to the start of classes. Attendance is mandatory for all new, transfer, and re-enrolling students, and must be completed before attending their first class.

PROGRESS POLICY:

Considering the varied capabilities of individual students, some may progress from one phase of training to another at a more rapid pace. However, all students must satisfactorily complete all subject matter prior to graduation unless credit has been allowed for previous training in a particular subject area. Successful graduates will be awarded an appropriate certificate upon completion of their training program based on the minimum requirements from the BBC (Board of Barbering and Cosmetology.)

ATTENDANCE, TARDY AND GRACE PERIOD POLICIES:

Attendance must be maintained at an average of 67 percent of the scheduled attendance. The student is expected to complete the course of study within 1.5 times of the period stated in the enrollment agreement. Students are required to make-up hours, lessons, and exams missed due to absenteeism only the grace period that starts at their scheduled end date. If hours are not completed by the end of the grace period see (Extra Instruction of this catalog) will apply. If the student is absent during two (2) consecutive weeks (fourteen (14) calendar days), the school will withdraw him/her. The Registrar in charge will review excessive tardiness or absences with the student to determine possible corrective action to the issue at hand.

CLASS & PRACTICE HOURS-CREDIT PROCEDURE:

Students at Elite Permanent Makeup & Cosmetology College record their attendance by clocking in/out on Genesis time-clock portal with their student number. Students will be allowed up to seven (7) minutes to clock-in and receive credit for the full quarter (1/4) hour. Students receive credit for task/operation/project completed after each action is verified by an instructor.

LEAVE OF ABSENCE LOA POLICY:

A Leave of Absence (LOA) is a temporary interruption in a student's program of study. LOA refers to the specific time period during an ongoing program when a student is not in academic attendance. The school may allow more than one LOA at its discretion. Students must request a Leave of Absence in advance unless unforeseen circumstances prevent the student from doing so, and that:

- The request must be in writing
- The request must include the students' reason for the LOA; and
- The request must include the student's signature

The reasons for which a leave of absence may be approved include:

- Personal and/or family medical issues
- Death in the family
- Vacation
- Other mitigating circumstances

The institution may grant an LOA to a student who did not provide the request prior to the LOA due to

unforeseen circumstances if:

- The institution documents the reason for its decision
- The institution collects the request from the student at a later date; and
- The institution established the start date of the approved LOA as the first date the student was unable to attend.

If approved, the official Leave will extend the contract period by the same number of days designated in the leave document or actually used by the student. No additional charges will be assessed as a result of LOA. A student granted an LOA in accordance with this policy is not considered to have withdrawn and no refund calculation is required at this time. The Leave of Absence and any additional approved leaves of absence may not exceed a total of 180 days in any twelve-month period. For federal aid recipients, the student's payment period is suspended during the LOA, and no federal financial aid will be disbursed to students while on Leave of Absence. Upon the student's return, the student will resume the same payment period and coursework and will not be eligible for additional Title IV aid until the payment period has been completed. If the student is a Title IV loan recipient, the student will be informed of the effects that the student's failure to return from a leave may have on the student's loan repayment terms, including the expiration of the student's grace period. A contract addendum will be completed and signed by all parties upon return from the LOA to extend the ending date by the applicable number of days. A student will be withdrawn if the student takes an unapproved LOA or does not return by the expiration of an approved LOA and the student's withdrawal date for the purpose of calculating a refund will be the student's last date of attendance.

RE-ENTRY POLICY:

Students who re-enroll in the program within 30 days of withdrawal date must complete the following:

- All outstanding tuition, fees, and overtime expenses must be paid in advance or the student must make satisfactory arrangements with School Director.
- Students are required to purchase a kit if their current kit is lost or stolen. Any missing kit items must be purchased and bring their kits up to date prior to reentering.
- Students will be contracted at the current tuition hourly rate.

NOTICE OF STUDENT RIGHTS

STUDENT'S RIGHT TO CANCEL:

A student, legal guardian, or sponsor has the right to cancel the Enrollment Agreement by written notice and obtain a refund of charges paid and will NOT withhold institutional charges exceeding \$250 if cancellation is made through the 1st class session or the 7th day after enrollment, whichever is later.

The school shall refund any amount paid by the student after it receives the notice of cancellation. Notice of cancellation may be given by mail, hand delivered, or (fax if applicable.) The notice of cancellation if sent by mail is effective when deposited in the mail, properly addressed with postage prepaid. The written notice of cancellation need not take any particular form and, however expressed, is effective if it states that the student no longer wishes to be bound by the Agreement.

REFUND POLICY:

After the cancellation period, the institution provides a pro rata refund of funds paid for tuition charges to students who have completed 60 percent or less of the period of attendance. Once more than 60 percent of the enrollment period in the entire course has been incurred (including absences), there will be no refund to the student. The registration fee of \$100.00 dollars is a non-refundable item. The STRF fee if applicable is non-refundable, student books and student kits are also non-refundable.

Students wishing to withdraw from the institution will provide a notice of withdrawal in writing and submitted to the School's Registrar. Students are officially withdrawn the date of notification from student or date terminated by the institution, 14th date of consecutive absences.

If the student has received federal student aid funds, the student is entitled to a refund of money not paid from federal student financial aid program funds.

Equipment, books, supplies, tools, uniforms, kits and all other items issued and received by the student are not returnable. Once received by the student it will belong to the student and will represent a liability to the student.

If the amount you have paid is more than the amount that you owe for the time you were scheduled to attend, then a refund will be made within 45 days of the official withdrawal date.

If the amount that you owe is more than the amount that you have already paid, then you will arrange to pay the amount that you owe to Elite Permanent Makeup & Cosmetology College.

All refunds will be calculated based on the students' last date of attendance. Any monies due to a student who withdraws shall be refunded within 45 days of a determination that a student has withdrawn, whether officially or unofficially. In the case of disabling illness or injury, death in the student's immediate family or other documented mitigating circumstances, a reasonable and fair refund settlement will be made.

- If permanently closed or no longer offering instruction after a student has enrolled, the school will provide a pro rata refund of tuition to the student or provide course completion through a pre-arranged teach out agreement with another institution if applicable.
- If the course is canceled subsequent to a student's enrollment, the school will either provide a full refund of all money's paid or completion of the course at a later time. If the course is cancelled after students have enrolled and instruction has begun, the school shall provide a pro rata refund for all students transferring to another school based on the hours accepted by the receiving school.
- OR provide completion of the course OR participate in a Teach-Out Agreement if applicable OR provide a full refund of all the money paid.
- Other miscellaneous charges the student may have incurred at the institution (EG: extra kit materials, books, products, unreturned school property, etc.) will be calculated separately at the time of withdrawal. All fees are identified in the catalog and in this enrollment agreement.
- If the student defaults on a federal or state loan, both the following may occur:
 1. The federal or state government or loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
 2. The student may not be eligible for any other federal student financial aid at another institution or other government financial assistance until the loan is repaid.

*The school is not currently eligible to participate in Federal Title IV Financial Aid Programs

DETERMINATION OF WITHDRAWAL FROM SCHOOL:

The withdrawal date shall be the last date of recorded attendance. The student would be determined to have withdrawn from school on the earliest point of:

- The date the school terminates your enrollment is due to academic failure or for violation of its rules and policies stated in the catalog.
- The date you fail to attend classes for 14 days and fail to inform the school that you are not withdrawing.
- The date you failed to return to school as scheduled by an approved leave of absence. The withdrawal date shall be the last date of recorded attendance. The date of the determination of withdrawal will be the scheduled date of return from LOA.
- A student is expelled by the school. (Unofficial withdrawals will be determined by the institution by monitoring attendance at least every 30 days.) In type 2, 3, 4 or 5, official cancellations or withdrawals, the cancellation date will be determined by the postmark on the written notification, or the date said notification is delivered to the school administrator or owner in person.
- For students who enroll and begin classes but withdraw prior to course completion (after three business days of signing the contract) the following schedule of tuition earned by the school applies.

SCHOOL OR COURSE CANCELLATION:

If the course is canceled subsequent to a student's enrollment, the school will either provide a full refund of all money's paid or completion of the course at a later time. If the course is cancelled after students have enrolled and instruction has begun, the school shall provide a pro rata refund for all students transferring to another school based on the hours accepted by the receiving school.

SCHOOL RULES AND REGULATIONS

CLASSROOM HOURS AND CLOCK IN TIMES

1. Between 9:00am -9:07am, students will be given a 7-minute grace period to get into their assigned class. Be advised that if you come in after the 7-minute grace period you will be deducted 1 hour of your time students will not be allowed into class until 10:00am.
2. Between 10:00am -10:07am students are given a 7-minute grace period to get into their designated class.
3. After 10:07am, **STUDENT IS NOT ALLOWED IN THE SCHOOL PREMISES AND CONSIDERED ABSENT FOR THE DAY, NO EXCEPTIONS.**

STUDENTS MUST FOLLOW CONTRACT SCHEDULE

- If students need changes within their schedule, you must notify the school's registrar.
- If students are leaving early because of an emergency first let your instructor know and clock out.
- Students are allowed to begin making up hours after their scheduled end date and must be approved by the registrar.
- Suspension or Termination
- Elite Permanent Makeup & Cosmetology College reserves the right to place students on probation or automatically terminated due to lack of attendance, unsatisfactory academic or bad behavior as well as not following any of the rules and regulations.

TIMECARDS OR RECORDSHEETS

- All time cards must stay in school at all times. Timecards are legal documents and must be treated with high importance.
- Please make sure all timecards are legible and neat.
- All time cards are to be kept in the school premises

TIME CLOCK TERMINAL

- Time clock terminal is the system that pulls all the time in and out for students.
- No student is allowed to clock in or clock out any student.
- *(If any student is caught doing this they will be terminated)
- All students are assigned with a student ID number, only you may know or have access to your own ID number.

CLASS PARTICIPATION

- Students must participate in all class activities. Activities include note taking, diagrams, quizzes and test taking.
- Students must complete all practical assignments assigned by instructor.
- Students must have all necessary tools for practice on a daily basis. If a student does not have tools for practice, they will be sent home with a warning. Tools include all practical supplies as well as full student kits.
- Class interruptions and disruptive behavior will not be tolerated in class or while student is in campus students will be given a verbal warning. If behavior continues it will be a written warning (3 warning writeups will become a suspension) These rules are designed to form excellent work habits and attendance.
- Students must respect classmates and teachers at all times.
- Stations and tools must be cleaned; disinfected before and after all operations.
- When on the clinic floor, or treatment rooms students must be at their stations practicing at all times
- Students must abstain from phone use during class time. (NO PHONES IN CLASS)

DRESS CODE AND APPEARANCE:

Students must always wear appropriate Clean Professional Look attire. A detailed dress code is provided during orientation.

- All students are required to wear their designated colored scrubs professional look attire.
- All students must wear the Student Name Tag (name tag replacement \$5.00)
- No shorts, short dresses, or short skirts are permitted. Dresses and skirts are allowed for religious purposes only. Skirts, and dresses must be at the knee or longer.
- No sleeveless tops, tank tops, spaghetti strap shirts, midriff tops, low cut tops that exposes extreme cleavage, nor revealing shirts.
- No hoodies are allowed, only black jackets or long-sleeved shirts under the course shirts.
- No pants with straps, revealing pants, and no ripped jeans with holes, low cut pants are allowed.
- Shoes must be closed toe and heel protective type shoe. No sandals, flip flops or open toe shoes. (Heels must not be higher than 2 inches and non-slippage.)
- No hats, caps, and bandanas allowed.
- No sunglasses unless it is prescription type eye wear prescribed by a doctor for medical reasons. No exceptions.
- Long hair must be pinned up for personal protection and for health and safety sanitation purposes.

Students are expected to practice good personal hygiene and maintain a clean, neat, and professional appearance always. Any student reporting to class inappropriately dressed will not be allowed to remain in the school and be sent home for the day. The time missed will be recorded as an absence.

After 3 written warnings the student will be subjected to a 1 week suspension, and placed in probation status for the remainder of training program.

NO CELL PHONES ALLOWED

- In classroom or hallways
- Cell phones may be used during break or outside in lunch area
- No headphones or Air Pod allowed

PERSONAL BELONGINGS

- Please be advised school is not responsible for lost or stolen items.
- Do not leave your belongings unattended. Make sure all of your belongings are put away before the end of your class time. Anything that is left behind is at your own risk.

IF YOU ARE CAUGHT STEALING

- You will be terminated from school no exceptions!
- Respect all school property, school supplies and classmates.

NO FOOD OR DRINKS IN CLASSROOM OR CLINIC STATION AREA

- Water or coffee only in a closed container.
- No drinks with straws
- This is due to State Board policy for sanitation purposes

WORK STATIONS AND TREATMENT ROOMS

- Do not personalize work stations with personal pictures, stickers etc.
- Work stations are assigned by the instructor only. You may be reassigned at any time by your instructor.
- Work stations must be clean and disinfected before clocking out at the end of the day
- Students must place all equipment used back to the designated area and disinfected before they clock out for the day.

PARKING

Campus does not have designated parking for students.

STUDENT KIT POLICY:

Each student must always maintain sanitation daily. All kits must be in a sanitized condition at the end of each day scheduled. Once student kits are issued and received by the student you are expected to have the necessary supplies, items, or equipment for the daily class schedules. The school maintains supplies for client use and instructor demonstration practical class only.

After three written warnings for failure to comply, the student will be subjected to a one week suspension and placed in probation status for the remainder of training program.

TERMINATION:

A fourth repeated violation warning constitutes insubordination and failure to comply with school policies. Any student subject to termination will be sent home. An official letter and appropriate paperwork documentation will be sent by certified mail. If the student owes money an unofficial record of transcript will be given until the student settles the debt owed to the school. Once the debt has been settled the official transcript and proof of training will be sent by certified mail.

IN GENERAL:

These guidelines are not all inclusive, as there may be other situations that may require action of the school. These guidelines may be revised at any time. They will then be posted on the bulletin board. These rules are designed to form excellent work habits and attendance, and to aid in completing your course as soon as possible so that you may become employed as a beauty professional in the beauty field.

SATISFACTORY ACADEMIC PROGRESS POLICY (SAP):

The Satisfactory Academic Progress Policy (SAP) is consistently applied to all students enrolled at the school. It is printed in this catalog to ensure that all students receive a copy prior to enrollment. This policy complies with the guidelines established by National Accrediting Commission of Career Arts and Sciences and the Federal regulations established by the United States Department of Education.

ATTENDANCE PROGRESS EVALUATION:

Students are required to attend a minimum of 67% of the hours possible based on the applicable attendance schedule in order to be considered maintaining satisfactory attendance progress. Evaluations are conducted at the end of each evaluation period to determine if the student has met the minimum requirements. The attendance percentage is determined by dividing the total hours accrued by the total number of hours scheduled. At the end of each evaluation period, the school will determine if the student has maintained at least 67% cumulative attendance since the beginning of the course which indicates that, given the same attendance rate, the student will graduate within the maximum time frame allowed.

If a student exceeds his/her Maximum Time Frame, he/she will be dropped from the program.

***TRANSFER STUDENTS**

Midpoint of the contracted hours or the established evaluation periods, whichever comes first. Evaluations will determine if the student has met the minimum requirements for satisfactory academic progress. The frequency of evaluations ensures that students have had at least one evaluation by midpoint of the course.

ATTENTION VA STUDENTS:

Educational benefits expire on the earliest of either the date you reach the total hours approved for your program, or on the date you complete or terminate your enrollment in the program.

DETERMINATION OF PROGRESS STATUS :

Students meeting the minimum requirements for academics and attendance at the evaluation point are making satisfactory academic progress until the next scheduled evaluation. These academic performances will be evaluated cumulatively at each evaluation period. Students will receive a hard copy of their Satisfactory Academic Progress Determination at the time of each of the evaluations. Students deemed not maintaining Satisfactory Academic Progress may be placed on warning.

GRADING SYSTEM:

Students are evaluated on a regular basis on theory, practical and clinical work. The evaluations are measured on a standard percentile basis and the percentage equated to a letter grade. Evaluation forms are issued to the students at the end of each evaluation period. The evaluation form reflects the overall Attendance (measured in actual hours & weeks) and Academic progress of the student. Students must maintain a "C" (75%) average to maintain satisfactory academic status. The system detailed below is the system utilized in the school.

DISCLOSURE OF EDUCATION RECORDS:

Student records for all students are kept at the College for six years. Transcripts and certificates earned are kept permanently. Students and parents/guardians of dependent minors may inspect and review their educational records. To do so, a student should submit a written request identifying the specific information to be reviewed. Should a student find, upon review, that records are inaccurate or misleading, the student may request that errors be corrected. If a difference of opinion exists regarding the existence of errors, a student may ask that a meeting be held to resolve the matter. Each student's file will contain student's records, including a transcript of grades earned. Students are not entitled to inspect the financial records of their parents. Written consent is required from the student (or his/her parent/guardian if the student is a dependent minor) before education records may be disclosed to third parties with the exception of accrediting commissions and governmental agencies so authorized by law.

Elite Permanent Makeup & Cosmetology College will keep student records on-site at 11961 Santa Monica Blvd, Los Angeles, CA 90025. Records of attendance and other information are available upon written request. This includes:

- The educational programs offered by the institution and the curriculum for each.
- The names and addresses of the members of the institution's faculty and records of the educational qualifications of each member of the faculty.
- Records of the name, address, e-mail address, and telephone number of each student who is/was enrolled in an educational program in that institution.
- The certificate granted and the date on which that certificate was granted.
- The courses and units on which the certificate degree was based.
- The grade(s), if any, earned by the student in each of those course.
- The transcript of the student.

PROBATION – MUST SUBMIT AN APPEAL TO BE ELIGIBLE

If the student has not met progress requirements, the student will be considered not making satisfactory academic progress. The student **MUST APPEAL** the satisfactory academic progress decision and prevail upon appeal. You have until the next evaluation period to bring your grades and/or attendance up to minimum requirements, or up to the requirements set forth in an agreed upon academic plan. If satisfactory performance is not achieved by the end of the probationary period according to satisfactory academic progress requirements or your academic plan, your financial aid will be interrupted and you will be responsible for payment of all tuition balances, if applicable. You will then be required to bring your grades and/or attendance up to satisfactory levels in order to have financial aid reinstated if applicable.

RE-ESTABLISHMENT OF SATISFACTORY ACADEMIC PROGRESS :

Students may re-establish satisfactory academic progress and Title IV aid, if applicable, by meeting minimum attendance and academic requirements by the end of the probationary period. Elite Permanent Makeup & Cosmetology College does not offer Title IV Funding at this time.

APPEAL PROCEDURE:

If a student is determined to not be making satisfactory academic progress, the student may appeal the determination within ten calendar days. Reasons for which students may appeal a negative progress determination include death of a relative, an injury or illness of the student, or any other allowable special or mitigating circumstance. The student must submit a written appeal to the school on the designated form describing why they failed to meet satisfactory academic progress standards, along with supporting documentation of the reasons why the determination should be reversed. This information should include what has changed about the student's situation that will allow them to achieve Satisfactory Academic Progress by the next evaluation point. Appeal documents will be reviewed, and a decision will be made and reported to the student within 30 calendar days. The appeal and decision documents will be retained in the student file. If the student prevails upon appeal, the satisfactory academic progress determination will be reversed and federal financial aid will be reinstated, if applicable.

INTERRUPTIONS, COURSE INCOMPLETES, WITHDRAWALS:

If enrollment is temporarily interrupted for a Leave of Absence, the student will return to school in the same progress status as prior to the leave of absence. Hours elapsed during a leave of absence will extend the student's contract end date and maximum time frame by the same number of days taken in the leave of absence and will not be included in the student's cumulative attendance percentage calculation. Students who withdraw prior to completion of the course and wish to re-enroll will return in the same satisfactory academic progress status as at the time of withdrawal.

STUDENT CLOCK HOUR POLICY:

The Board of Barbering and Cosmetology will only recognize Genesis digital clock-in system punched hours of attendance, as a result of this requirement this school can only give clock hour credit to students who record their attendance by using the time clock to clock in and out at the start and end of their class day and lunch period. A thirty (30) minute lunch break shall be taken when a student attends a 4-hour class day or more. If you are attending less than a 4-hour class day and desire to take a lunch break (30 minutes), then the half hour must be deducted from your daily total and you must clock in/out on your timecard for the lunch break. At the completion of the day, your timecard is prepared from the current weekly timecard. The daily hours and operations earned are added to the totals in the prior column and final totals transferred to the cumulative column. These cumulative figures are then entered in the prior column on the weekly timecard. The timecard must be signed by the student and the instructor daily. Instructors may not sign a student in or out and if a student does not clock in or out at lunch, 30 minutes for lunch will be deducted. After clocking in you are required to maintain applied effort. Timecards reflect the student's daily record of hours and operations. It is important that all your hours and operations are recorded properly and accurately. The attendance personnel must be able to read your timecard so that the hours and operations are transferred correctly to the roster. The timecards are the property of the school and must remain in the school at all times. Timecards must be retained/stored in their entirety for 6 years by the school.

NONCREDIT, REMEDIAL COURSES, REPETITIONS

Noncredit, remedial courses, and repetitions do not apply to this institution. Therefore, these items have no effect upon the school's satisfactory academic progress standards.

ATTENDANCE STATUS:

Full time: Any student scheduled to attend 30 hours or more per week is considered to be a full-time student. Part-time enrollment is defined as 22.5 hours per week.

TIMECARD CREDIT:

The following is a guideline for the instructor to issue credits.

- Each Theory must be initialed in the proper category. If that category is complete, the instructor may issue credit in a comparative category.
- The portion of the timecard reflecting hours are in the Theory hours earned and any classes the instructor has demonstrated.
- The portion of the timecard concerning operations are to be applied efforts of the students as they manually perform practical subject.

Personal grooming, leaving the building, reading material not related to your training or activity not related to your training are not tolerated. If this occurs, you will be asked to stop such activity or to punch out for the remainder of the day. Continued activities of this nature could result in your termination.

HEALTH AND PHYSICAL CONSIDERATIONS:

Professional in the beauty fields must be in good physical health for he/she will be working in direct contact with patrons. In most aspects of the beauty culture fields there is a great deal of standing, walking, pushing, bending and stretching, and sometimes for long periods of time. A person must consider his/her physical limitations in terms of making a career choice that involves extensive training. We promote the acceptance of students with physical limitations or disabilities if these students believe they can fulfill training demands. If a female student is pregnant prior to enrollment, she must furnish a letter from her Medical Doctor stating she can work around chemicals and withstand the long hours of standing. This letter must be furnished to enrollment personnel prior to her enrollment. In the case whereas a currently enrolled female student becomes pregnant, she must inform the school and furnish a letter from her Medical Doctor stating she can continue in the course and work around chemicals and withstand the long hours of standing.

STUDENT SERVICES

Elite Permanent Makeup & Cosmetology College maintains a focus on the delivery of educational services. Should a personal problem which interferes with his or her ability to complete coursework occur, we will provide assistance in identifying appropriate professional assistance in the student's local community but does not offer personal counseling assistance. Placement services, career counseling and drug counseling referral services are available to enrolled students of this institution.

PROOF OF TRAINING & TRANSCRIPTS:

The first official Proof of Training (POT) or transcript is provided at no charge. Subsequent copies are available upon advance payment of the POT or transcript fee of \$25.00 for two copies. POTs and Transcripts will only be released to the student upon receipt of a written request bearing the student's live signature. No POT or transcript will be issued until all tuition and other fees due to the institution are paid.

CAREER COUNSELING AND PERSONAL ATTENTION:

Students are counseled individually, as often as necessary but at least every four weeks to review the student's progress and adjustment. Successful Beauty professionals are scheduled into the school regularly to give demonstrations and to discuss career goals with the students. This activity supplements the daily counseling carried out by the instructors and supervisors. Students may request additional counseling sessions at any time. Students are given personal attention assistance at every stage of training from the first day of enrollment to the day of graduation. At predetermined intervals, assessments are utilized to evaluate the rate and quality of the student and remedial assignments are made when required. Particular attention is given to preparation for the Board of Barbering & Cosmetology Examination during the last 100 hours of their course program.

PLACEMENT POLICY:

Upon graduation, the process of follow-up begins. When students take the licensing examination, it is recorded as a pass or fail. After passing the exam, students are encouraged to return for placement assistance by reviewing the listings of salons, shops and spas seeking employees, the requirements, salary, and other pertinent information. Job placement assistance is provided to graduates and students at no additional charge. **The school does not guarantee placement to any student.**

DRUG ABUSE PREVENTION PROGRAM:

Elite Permanent Makeup & Cosmetology College makes the following information available to its students, staff, and instructors. Any individual who is seeking information, counseling, or assistance concerning Drug Abuse and/or Prevention may speak director so receive further information.

VISA SERVICES:

This institution does not admit students from other countries, so no visa related services are offered.

GRIEVANCE- COMPLAINT POLICY AND PROCEDURE:

Persons seeking to resolve problems or complaints should first contact the instructor in charge. Requests for further action may be made to the School Director or person in charge. Complaints to the Director must be in writing and submitted to the Director. The Director will respond to the written complaint within 7 business days to resolve the issue(s). The response from the Director will be in writing to the complainant. All complaint documents will be filed in the Director's office. Should the complaint be against the Director, the complaint should be sent to the Owner, Mahnaz Bahaelou The Compliance Administrator will respond within 7 business to resolve the issue(s). The response from the Compliance Administrator will be in writing to the complainant.

BARBER AND COSMETOLOGY COURSES OF STUDY

COSMETOLOGY COURSE: (SOC 39-5012.00, CIP Code 12.0401)

The course of study for students enrolled in the Cosmetology course shall consist of one thousand (1,000) clock hours of technical instructional and practical operations covering all practices constituting the art of cosmetology. Educational Goals: The Cosmetology course of study is designed to prepare students for the state licensing examination and for profitable employment as a Cosmetologist (SOC #39.5012). A Cosmetologist must be licensed to practice in the state of California.

ESTHETICS COURSE:(SOC 39-5094, CIP Code 12.0409)

The course of study for students enrolled in the Esthetics course shall consist of six hundred (600) clock hours of technical instructional and practical operations covering all practices constituting the art of skin care. Educational Goals: The Esthetics course of study is designed to prepare students for the state licensing examination and for profitable employment as an Esthetician (SOC #39.5094). A Esthetician must be licensed to practice in the state of California.

MANICURING COURSE:(SOC 39-5092, CIP Code 12.0410)

The course of study for students enrolled in the Manicuring course shall consist of four hundred (400) clock hours of technical instructional and practical operations covering all practices constituting the art of manicuring. Educational Goals: The Manicuring course of study is designed to prepare students for the state licensing examination and for profitable employment as a Manicurist (SOC#39.5092). A Manicurist must be licensed to practice in the state of California.

HAIRSTYLING COURSE: (SOC 39-5012.00, CIP Code 12.0401)

The course of study for students enrolled in the Hairstyling course shall consist of six hundred (600) clock hours of technical instructional and practical operations covering all practices constituting the art hairstyling. Educational Goals: The Hairstyling course of study is designed to prepare students for the state licensing examination and for profitable employment as a Hairstylist (SOC#39.5012). A Hairstylist must be licensed to practice in the state of California.

ADMISSION REQUIREMENTS:

Enrollees are admitted as regular students under the following criteria:

- Complete an Application Form Complete and submit the application form to the school prior to registration. All forms may be obtained by requesting time from Elite Permanent Makeup & Cosmetology College, 11961 Santa Monica Blvd, Los Angeles, CA 90025
- Government issued picture identification;
Examples :
 - **Valid Passport/Green Card**
 - **Valid Official US State ID or Drivers License**
- Social Security **or** ITIN Card; **and**
- High School or College Diploma or High School or College Transcript (that clearly states you have met all graduation requirements), **or** GED, California State Proficiency Test or its equivalent.
- If Home Schooled, a valid certification document provided by the state in which you were homeschooled must be provided and it must be equivalent to a High School Diploma, **OR**
- For a student that graduated high school outside the United States, they must have the High School Diploma translated into English by an outside agency qualified to translate documents into English and confirm the academic equivalence to a U.S. High School Diploma.

A Cosmetology, Esthetics, Hairstyling or Manicurist applicant lacking the High School Diploma or its equivalent, must be at least 18 years old (compulsory school attendance in California), must have completed the 10th grade education level or its equivalent as required by the California Board of Barbering and Cosmetology and must take the Ability to Benefit Exam (ATB.)

Our school does not recruit students already attending or admitted to another school offering a similar program of study.

Elite Permanent Makeup & Cosmetology College has not entered into an articulation or transfer agreement with any other college or university.

Elite Permanent Makeup & Cosmetology College does not give credit nor hours for experiential learning.

TRANSFER POLICY/CREDIT EVALUATION:

Appropriate credit will be granted for prior training or experience upon review and verification of an official proof of training document by the Board of Barbering and Cosmetology and the prior schools official transcript. Occasionally, a student's acceptance by Elite Permanent Makeup & Cosmetology College will depend entirely on the Board of Barbering and Cosmetology approval of prior training.

Elite Permanent Makeup & Cosmetology College will maintain a written record of transferable hours and credits students will be granted an academic plan to complete all required subjects hours and credits.

- Students who have had training outside the State of California must provide proof of the number of hours of training to the Board of Barbering and Cosmetology and Elite Permanent Makeup & Cosmetology College prior to enrollment.
- Transfer students are responsible to purchase the education kit at an additional cost and the tuition.
- Please note that students transferring to another school may not be able to transfer all hours they earned at Elite Permanent Makeup & Cosmetology College. The number of transferable hours depends on the policy of the receiving school.

STUDENT CHARGES WITH PRIOR HOURS

Students that are accepted for enrollment with prior hours will be charged as follows: registration fee, kit/books/supplies, and tuition based on hours needed multiplied by the current hourly rate.

NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION:

The transferability of credits you earn at Elite Permanent Makeup & Cosmetology College is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the certificate you earn in the program is also at the complete discretion of the institution to which you may seek to transfer. If the certificate that you earn at this institution is not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason, you should make certain that your attendance at this institution will meet your educational goals. This may include contacting an institution to which you may seek to transfer after attending Elite Permanent Makeup & Cosmetology College to determine if your certificate will transfer.

PRIOR HOURS POLICIES AND PROCEDURES:

Prior hours will be granted to students with training from a licensed Cosmetology school in California with proper documentation for training obtained that is identical to training provided by Elite Permanent Makeup & Cosmetology College. In addition, the College will supply Spanish-language textbooks, instructional guides, and tutorial materials to facilitate student comprehension and effective communication throughout the training program.

The College has evaluated the demand for Spanish-language courses among current and prospective students by collecting feedback from individuals whose primary language is Spanish or who prefer instruction in Spanish. In lieu of formal language proficiency or written examinations, the College will utilize alternative methods to assess Spanish fluency. These assessments will be conducted verbally to determine a student's ability to effectively engage in Spanish-language instruction. The following methods will be implemented:

1. Conversational Assessment – Students will participate in a structured conversation with an evaluator or instructor, who will assess the student's ability to comprehend and respond appropriately in Spanish. Discussions may address a variety of topics, enabling the evaluator to assess vocabulary, grammar, fluency, and overall communication skills.
2. Informal Conversation – Students may participate in unstructured discussions with instructors or native Spanish-speaking staff members. These conversations, which may cover a range of topics, allow evaluators to informally assess vocabulary breadth, conversational ease, and general fluency.

Based on the assessed level of interest and demand, the College will begin incorporating Spanish-language courses into the schedule on a gradual or as-needed basis. Initially, one or two courses may be offered per semester, with the number of offerings increasing as demand grows. The College is committed to a thoughtful and strategic approach in phasing in Spanish-language instruction to ensure it meets the needs of the student population. ADMISSIONS PROCEDURES PMU

As a prospective student, you are required to contact Elite Permanent Makeup & Cosmetology College to discuss your personal education and career plans with Training Center staff prior to enrolling or signing an enrollment agreement. We gladly accept international students, but will not provide nor support any visa services or visa application you may require to enter the United States legally. We will inform you of enrollment agreement policies and procedures. This way you can assure yourself in advance that our programs and our educational philosophy are the right fit for you before you make your final decision.

As a prospective student, you are encouraged to review this catalog prior to signing an enrollment agreement. You are also encouraged to review the School Fact Performance Sheet which must be provided to you prior to signing an enrollment agreement. Students must meet specific requirements prior to signing an enrollment agreement and must meet additional requirements prior to actually starting school.

1. Participate in a Blood Borne Pathogen (BBP) Online Training.

We recommend Elite Bloodborne Pathogens Training. The cost is **\$29** for 2 hours, taken annually. This fee is not included in tuition fees. This training must be completed for Los Angeles County before the enrollment agreement is signed.

2.Registration as a Body Art Practitioner through the Los Angeles Health Department

We will take care of registering you as long as you provide all necessary documentation. The fee for taking care of this is **\$100** and is not included in course fees. You will need to provide the following:

- One (2"X2") photo
- A copy of your unexpired ID/DL/Passport
- A copy of your certificate of completion of blood borne pathogen training
- One of the following regarding Hepatitis B vaccination:
 - Laboratory Evidence of Immunity
 - Certification of Completed Vaccination
 - Vaccination Declination

3.The following items are required for enrollment at Elite Permanent Makeup & Cosmetology College

- A copy of your unexpired ID/DL/Passport
- Completed Enrollment Agreement
- Completed (initialed) School Performance Fact Sheet
- Certificate of completion of Blood Borne Pathogen training
- Any additional certification or licensing
- International Students will be required to provide proof of travel visa

Elite Permanent Makeup & Cosmetology College does not offer English as a Second Language (ESL) programs. The programs are taught in English. You must demonstrate proficiency in speaking, comprehending and communicating effectively in the English language. International students whose primary language is not English must present documentation of proficiency, such as TOEFL (Score of 18 or above).

PMU CLASSROOM RULES AND REGULATIONS

- Each student must conduct themselves in an honorable and ethical manner, showing professionalism, dignity & respect for your fellow students, instructors, all clients & models.
- Using your phone on the floor (work area), when taking before and after photos of your clients/models is allowed. Otherwise, phones are to remain in your pocket or in the classroom area.
- Phones are not allowed on trays, chairs or stands, to prevent cross contamination. Please, always turn your phones on silent or vibrate before you enter the studio.
- Phones are not to be used during class. Calls may be taken outside the studio, on your own time, such as during lunch/breaks.
- We get permission from our clients and models for our students to "observe the process." Therefore, it is important that the students always allow the instructors and students focus on their clients while they are working. There is to be no unnecessary talking to, or near the instructors/students while they are working. If you have a question or absolutely have to say something - you may ask quietly. Otherwise, write down your questions to be asked after the procedure is completed.
- Unfortunately we have no parking available for students or clients, anyone parked in our private lot will be towed. Everyone is to park elsewhere, we recommend parking on Saltair or Brockton. There is an un-metered residential parking area on both side streets.
- You may take two 15 minute breaks and one 30 minute lunch break. You can bring your own lunch or dine out.
- Be mindful of others and keep the kitchen and classroom clean at all times; anything left out will be thrown away, daily.
- We only allow the models & students in the procedure areas during class time. We do not allow friends or family members in the procedure areas. Please ask your friends/family to meet you in the reception area or in outside the studio for breaks or after class.
- You are allowed to have no more than one model on "model day." Models will either have previous work requiring a touch up, or require new services. Which type of model you will receive cannot be guaranteed.

- After you complete your procedure on your model, you will receive a certificate, per whichever course was completed.
- After graduation, you are allowed to bring in clients into our studio. The first three chair rentals are free, and after the third, there is a fee of \$95 to rent a chair. The fee is the same regardless if the procedure is a touch up or first time.
- In order to graduate you must have completed work on your model, and you must pass written/practical exam. Practical exam will be graded on the following; performance, sanitation before, during and after procedure, and the ability to follow instruction. If one of these requirements is not met, we will hold your certificate until you pass all exam fully.
- Please, always respect instructors time & classroom time.
- Elite PMU follows all BPPE standards for all and not limited to refund policy, tuition standards, as well as teaching standards.
- There is a zero-tolerance policy in the use of recreational or medical drugs, alcohol, or any other substance that can impair or endanger yourself or any other person.

PMU CANCELLATION POLICY

You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro-rata refund if you have completed 60 percent or less of the scheduled days/hours in the current payment period in your program through the last day of attendance. A student, legal guardian, or sponsor has the right to cancel the Enrollment Agreement by written notice and obtain a refund of charges paid except the \$250.00 non-refundable registration fee, STRF if applicable, student books, and student kits after the cancellation period from the date the enrollment agreement was signed.

PMU INTERNSHIP PROGRAM (HIGHLY RECOMMENDED/NOT MANDATORY)

Select students will be granted one month immediately following receipt of their Certificate to utilize this program. The program will allow students to build their business on-site. You will be required to bring your own models on-site so you may refine your skills under the watchful eye of our highly trained professionals. Should you need guidance or encounter complications, we will be there to assist you. You will use our facility, our equipment, and be covered under our insurance policy. You will be required to use Elite Permanent Makeup & Cosmetology College products only. The duration of this program is exactly one calendar month. This program expires exactly one calendar month after you receive your Certificate. There are no exceptions to the length of this program. You may not delay the start of this program under any circumstance. It must begin immediately after completion of the Certificate course. Chair appointments are reserved for Mon-Wed, 10am-4pm and Sat 10am-2pm.

If a student does not graduate for these reasons listed below, please follow the Incomplete Course Protocol.

- Did not pass final exam
- Did not begin final exam
- Did not get passing grade on quizzes
- Has an overall low grade
- Did not complete the course

PMU INCOMPLETE COURSE PROTOCOL FOR PERMANENT MAKE UP

If the student is not graduating on their scheduled graduation day, Elite Permanent Makeup & Cosmetology College will hold their certificate until they retest and pass.

- The student has 3 (three) months to retest with a total of 3 (three) attempts to pass.
- The student will be given 2 (two) additional attempt to pass the course after their first attempt.
- It is the students responsibility to schedule a retest date if they leave the facility without setting a retest date.
- The student has the option to sit in on 1 (one) day of a future class (within 3 months) to refresh their skills.
- The student will need to reschedule on another graduation date to retest.
- The student still have the option to bring a model or we can provide one for them.

Upon retesting and passing the student will receive their Certificate of Completion.

If a student does not pass during their first three attempts, they are required to pay for and attend a refresher course, which is discounted from the full price of the initial course. Refresher courses range in price depending on which course needs to be retaken, contact us for further details on pricing.

PMU FOLLOW UP GRADUATION PROCESS

By the end of the year, we make sure that every graduate from our courses has been contacted. We want to follow up to see if they are working in the Permanent Makeup Industry and if they need assistance with anything regarding training. If they are currently working in the field please get their employers information for our records. We want to make sure every student is satisfied with training they have received and has access to all the resources we can offer.

PMU PHYSICAL DEMANDS

Prospective students should be aware of the physical demands of an occupation as a Permanent Makeup Artist. Such occupations generally require continued standing and constant use of the upper torso, shoulders, arms, wrist, and hands, upper back and neck, constant sitting which can lead to backaches, and wrist/arm/hand problems. Certain individuals may have allergies and sensitivity to chemical; products used in the profession. A student must be physically capable of performing all required activities conducted at the school. Standing/sitting for prolonged periods of time can be a necessity for beauty education and the professions.

PMU EARNINGS AND OCCUPATIONS

As with any career, the amount of earnings one can obtain in the beauty industry is directly related to the amount of effort one applies to their career. Minimum efforts can result in minimum wage rates, while maximum efforts can lead to much higher levels of compensation. For this reason, EPMCC does not provide specific dollar earnings information. One's ability to earn income in the beauty industry is very dependent upon one's ability to communicate, present oneself professionally, develop great people skills and maintain a positive attitude. EPMCC curriculum is designed to teach students these skills, but the effort students put forth is up to them. PMU artists may earn income through different career choices. Occupations include: Full time PMU artist, Part-time PMU artist, scar specialist, barbers who advance their services to scalp micropigmentation, dentists, estheticians broadening services, nurses broadening services, to name a few. Artists can find employment in salons, spas or dermatologists offices. In addition to the above stated factors, earnings levels can depend on location, tipping habits, competition, self-employment, the company one chooses to work for, or the position held.
